This program started in 2020. So far, 35 students from their final years have had the opportunity to apply the knowledge acquired at the university in the field. What makes us happy is that 6 of them have already found their place in the Greengold team, one of them in the last year (2023).

- You have the flexibility to travel – having a driving license can be an advantage.
- You appreciate the fact that at the end of the internship period you can benefit from a private scholarship granted by our partner **Association Dia.Logos** from Sibiu, for the academic year 2023-2024 or 2025-2026.

### Procedure :

- Following the analysis of the forms received together with the internship organizers, we will select certain candidates who will be invited to sign the administrative documents necessary for the internship and will receive access to a mobile application for planning the internship activities;
- The planning of the practice days will be done dynamically by the mentoring colleagues Regional Coordinators - RC using a mobile application. The practice activities and the possible number of participants will be periodically posted on the mobile application by the RC colleagues and available candidates, from areas close to the venue, can sign up. RC colleagues will analyze and select from the list of registered persons the participants for each activity to optimally organize the activity in the field.

Activities that can be carried out during practice (the list is indicative and may undergo changes depending on the study curriculum of each practitioner):

1. Marking trees: Designation of a forestry itinerary for a given stand, choice of trees to be harvested, collection of biometric data, instruction in the use of the specific mobile application.
2. Thinnings: The choice of future trees and those to be extracted, the analysis of intra-parcel accessibility and the development of a proposal regarding its improvement
3. The construction and materialization of existing harvest roads in the forests where wood will be harvested in 2024 and 2025.
4. Identification and materialization of biodiversity trees/protected species in Natura 2000 sites, analysis, and establishment of specific conservation measures, etc.
